### **Annex 8 Further Players**

#### 8.1. German Academic Exchange Service

In 2012 and 2013, the German Academic Exchange Service (DAAD) funded a total of 24 scholarships worth about €160,000.

#### 8.2. Senior Expert Service

The Senior Expert Service (SES) seconds highly qualified retired experts on short-term missions. Since 1995, SES has carried out a total of 201 assignments in Cambodia; 38 assignments in 2012 and 20 assignments until October 2013.

# 8.3. Development Volunteers Service "weltwärts" ("world-wards") Programme

Currently there are 22 "weltwärts" volunteers in Cambodia working with 8 partner organizations. The volunteers carry out work primarily in the areas of childcare and education, people with disabilities, health care and environment. The idea behind the volunteer service is the successful formula of "learning by serving". It will enhance intercultural understanding and help increase awareness and acceptance within society of how development policy issues impact on our common future.

#### 8.4. Civil Peace Service

The Civil Peace Service (CPS / GIZ) is working to support reconciliation and justice in the context of the Khmer Rouge Tribunal. Nine civil peace advisors are part of the CPS programme. Both sides agreed that the CPS would continue its activities in the area of legal advice, as well as in the fields of reconciliation, remembrance, mental health and media. The civil peace advisors work at the Royal University of Phnom Penh and several civil society organizations in the fields mentioned above.

## 8.5. Non-governmental cooperation (political foundations, churches, NGOs)

Substantial support is being provided in many areas by non-governmental organizations, churches and political foundations. While they receive financial support from the German Federal Ministry for Economic Cooperation and Development, these organizations are fully responsible and accountable for their activities.

The Konrad Adenauer Foundation and Heinrich Böll Foundation have offices in Phnom Penh, while Friedrich Ebert Foundation, Friedrich Naumann Foundation, Hanns Seidel Foundation, and Rosa Luxemburg Foundation provide support through their regional programmes.

The DGRV - Deutscher Genossenschafts- und Raiffeisenverband e. V. - a German cooperative apex organization and auditing federation, is providing long-term support for strengthening cooperative structures and networks in Cambodia. DGRV contributes to the promotion of the agricultural sector in Cambodia by strengthening rural enterprises (cooperatives). DGRV is cooperating closely with the Ministry of Agriculture, Forestry and Fisheries, as well as with NGOs involved in this field. The German delegation appreciates the Cambodian government's willingness to provide DGRV with the formal prerequisites for its work.

#### 8.6. Deutsche Welle Akademie (DW Akademie)

Together with the Department of Media and Communication and the Women's Media Centre, DW Akademie has supported the professional training of Cambodian journalists and media professionals since 2006. DW Akademie has strengthened local media and supported high standards of journalistic quality. Currently, in cooperation with all relevant stakeholders, DW Akademie is developing a medium-term strategy to enhance and broaden its support in order to foster media development and the training of journalists in Cambodia.

#### 8.7 DEG – German Investment and Development Company

DEG – German Investment and Development Company has the mandate to finance private sector investment in developing countries and is wholly owned by KfW Group. In Cambodia, DEG is offering loans to local banks and microfinance institutes to ensure credit lines to small and medium-size enterprises. Currently, DEG is providing loans to Acleda, Prasac and Sathapana worth \$80 million.

#### 8.8. Public-Private Partnerships (develoPPP)

The German delegation highlighted public-private partnerships, which strengthen the effects of official development cooperation and private business activities by co-financing mutual projects.

In 2013 alone, four so-called integrated public-private partnerships were implemented in cooperation with the Regional Economic Development Programme with total funding of €50,000.

DEG is currently financing four public-private partnership activities in Cambodia: one on mining technologies with GUB, one on solar dryer technology in cooperation with Bayer, one in cooperation with the German textile company Maag and one with German shoe producer Puma, with a total budget of €3.6 million.

Under develoPPP, GIZ is cooperating with Wagner Kieswerke to establish a recycling centre in Phnom Penh (total budget €485,400).
