






Total Investments 2009-2014




Investments Inside/Outside SEZ 2009-2014



Cooperation under ASEAN-JAPAN Centre (2009-2014)

- > Seminars on Cambodia's Investment Environment in Japan (once a year) and other countries in the region. (5 times)
- ➤ Study tours on Investment Promotion Policy to various countries in the region including Indonesia and Vietnam. (3 times)
- ➤ Visit of Japanese delegations exploring investment opportunities in Cambodia. (2 times)

Cooperation with Ministry of Economy, Trade, and Industry (METI)

CDC in cooperation with METI conducted seminars in Cambodia 3 times since 2010. The 3rd Seminar on Economic Development in Cambodia took place on 25th October 2012 in Phnom Penh with participation of around 120 Japanese investors.

Partnership with Keidanren

Keidanren always pays annual visit to Cambodia. In February 2013, Mr. Yonekura Hiromasa, Chairman of Keidanren, along with 64 members paid visit to Cambodia to explore investment development and opportunities and was also received by the Prime Minister.

Relationship with Japan-Mekong Business Cooperation Committee

- In December 2013, senior CDC officials attended the seminar on Investment Environment and Opportunities in Cambodia and had sideline meeting with Mr. Kohei Watanabe, Chairman of Japan-Mekong Business Cooperation Committee along with 44 delegates representing big Japanese companies in Tokyo, Japan.
- In February 2014, senior CDC officials attended the forum for the Promotion of Public-Private Cooperation in Mekong in Tokyo, Japan.
- In March 2014, Mr. Kohei Watanabe, Chairman of Japan-Mekong Business Cooperation Committee, along with 30 delegates received courtesy call from the Prime Minister.
