## Decision

On The Guideline for the Annual Consultative Meeting Between the Royal Government of Cambodia and Non-Governmental Organisations

## **Royal Government**

- · Having seen the Constitution of the Kingdom of Cambodia;
- Having seen the Royal Decree No. NS/RKT/0908/1055 dated 25 September 2008 on the Formation of the Royal Government of Cambodia;
- Having seen the Royal Decree No. 02/NS/94 dated 20 July 1994 promulgating the Law on Organization and Functioning of the Council of Ministers;
- Having seen the Sub Decree No. 149 SD. BK dated 03 October 2008 on the Organization and Functioning of the Council for the Development of Cambodia;
- Pursuant to the request of the Deputy Prime Minister, Minister of Economy and Finance and First Vice-Chairman of the Council for the Development of Cambodia;

### Thereby Decided

## Article 1:

The consultative meeting between the Royal Government of Cambodia and Non-Governmental Organizations shall be conducted annually in the first quarter of the year or as per decision of **Samdech Prime Minister**. The preparation and the conduct of the meeting shall be in accordance with the guideline attached herewith.

## Article 2:

**H.E. Keat Chhon**, Deputy Prime Minister, Minister of Economy and Finance and First Vice-Chairman of the Council for Development of Cambodia, shall have the overall responsibility for the coordination and conduct of the meeting, and shall regularly report to **Samdech Prime Minister** on the progress of the preparation for the meeting and shall seek approval from Samdech Prime Minister on documents relevant to the meeting.

### Article 3:

The Cambodian Rehabilitation and Development Board of the Council for the Development of Cambodia (CRDB/CDC) under the overall management of H.E Chhieng Yanara, Minister attached to the Prime Minister and Secretary General of CRDB/CDC, shall be the Secretariat of the meeting. In the preparation for the meeting, CRDB/CDC shall collaborate with relevant ministries and agencies of the Royal Government and with the Non-Governmental Organization Coordination Group of concerned sector and shall report progress to Deputy Prime Minister Keat Chhon.

#### Article 4:

The Minster in charge of the Office of the Council of Ministers, the Minister of Economy and Finance, the Minister of Foreign Affairs and International Cooperation, Ministers and Secretaries of State of all ministries and

state secretariats of the Royal Government, the Council for the Development of Cambodia, and the aforementioned officials shall implement this Decision from the date it is signed.

### Article 5:

This Decision shall take effect from the date signed.
